

Abstract

In this talk, I will review the idea of staggered multi-field inflation models. These models contain fields that disappears suddenly during inflation. The staggered inflationary models can address some properties of observational data e.g. bumps and rips in CMB data. I argue that staggered inflationary models can be embedded in models of brane inflation.
